Background:

The Royal Hospital for Children in Glasgow and the wider Women and Children' Directorate in NHS Greater Glasgow and Clyde, in partnership with Glasgow Children's Hospital Charity, is establishing a Centre for Children's Health Innovation.

Our ambitious vision is to create a world-class centre of excellence co-developing, evaluating, and implementing cutting-edge technologies to transform the health and well- being of children and young people locally, nationally and globally.

Our centre has a long-standing reputation for developing medical technologies with global impact over the past 60 years. During the digital revolution of the past decade we have already codeveloped new software and devices that are transforming care delivery and health internationally.

Interim Director:

We are looking for a highly skilled individual to join our high-functioning and ambitious team who can help to shape, share and deliver this vision. This unprecedented opportunity requires a unique combination of skills and experiences including project management, team building, business development, leadership, marketing development, research, and innovation development.

Key activities of the Centre for Children's Health Innovation will be:

- 1) Engaging children, young people, their families and carers, and clinical teams to discover what really matters to them and what challenges they want to address.
- 2) Building collaboration with partners in industry from consultancies to SME's, PLC's, and global corporates, to academia and the third sector.
- 3) Build a clear commercial and marketing strategy to ensure the Hub flourishes and thrives.
- 4) Develop and support a clear innovation process including engagement, collaboration, co-design, evaluation, procurement, and implementation of technology-based solutions addressing health and wellbeing challenges of children.
- 5) Engage and align with national health and innovation strategy.
- 6) Working with Regional Innovation Test Beds and NHS organisations to support innovation consortia and collaborations through the innovation process.
- 7) Leveraging support, resource and funding from the national innovation ecosystem, including Scottish and UK Government, industry support, research and innovation funders, and private equity and investment.
- 8) Develop the profile and impact of the centre as a world-leader in children's health innovation.

Scope of work will include:

- Develop the overarching strategy for the centre, in conjunction with the Innovation Clinical Director and Leadership Board.
- Delivery of regular management reports for full transparency for investors and the wider leadership team.
- Development of a brand-identity and associated marketing strategy for the centre, and implementation of an accompanying communications strategy in conjunction with communication teams in NHSGGC, West of Scotland Innovation Hub and Glasgow Children's Hospital Charity.
- Development and delivery of an engagement strategy for children and young people, their carers and families, clinical teams and third parties.
- Identification of key priority areas for innovation and build project coalition.
- Launch innovation funding programmes aligned to key priority areas.
- Co-ordination of innovation projects locally, regionally, and nationally.
- Development of collaborations locally, nationally, and internationally, with industry partners, including SMEs and established life science and technology providers, through professional networks and events, trade organisations and enterprise groups.
- Development of collaboration with potential funders.
- Close collaboration with the West of Scotland Innovation Hub and wider NHS Scotland Innovation ecosystem in order to support local projects through the innovation journey.
- Co-ordination of funding applications and bids to support innovation projects and growth of the Centre.
